IPTV TERMS AND CONDITIONS

- 1) By signing this registration form and agreement, you (Customer) must be at least 18 years of age and agree to the following terms and conditions of the service described below.

- 2) These services are provided by **Reynolds Cable, Inc. P.O. Box 27, Reynolds, IL 61279**. This agreement shall be governed by and construed in accordance with the laws of the state of Illinois applicable to contracts to be performed entirely within the state.

- 3) The modem, set top box(s) and remote(s) will be provided by **Reynolds Cable, Inc.** In consideration for **Reynolds Cable, Inc.** providing this equipment, Customer agrees to pay the set up fee and the monthly service fee for chosen services. Both **Reynolds Cable, Inc.** and Customer may terminate this Agreement at any time. Customer is obligated to pay for service through the termination date.

- 4) All equipment provided is the property of **Reynolds Cable, Inc.** At the termination of service all equipment must be returned to **Reynolds Cable, Inc.** in good working condition. Any equipment damaged through neglect, misuse or abuse will be replaced at the customer's expense. **Customer agrees to protect Reynolds Cable, Inc. equipment from electrical and phone line surges by using surge protector(s).**

- 5) Battery replacement is the customer responsibility.

- 6) All charges will be billed by **Reynolds Cable, Inc.** on your **Reynolds Telephone Company** bill on the fifth of each month, payable by the 26th of that same month. Failure to pay by the specified due date may result in your services being discontinued. A reconnect fee of \$15.00 will be required to reestablish service.
