WIRELESS INTERNET TERMS AND CONDITIONS

1) By signing this registration form and agreement, you (Customer) must be at least 18 years of age and agree to the following terms and conditions of the service described below.

2) These services are provided by **Reynolds Cable, Inc. P.O. Box 27, Reynolds, IL 61279** in conjunction with WINS, PO Box 359, Colchester IL 62326 and Spirit This agreement shall be governed by and construed in accordance with the laws of the state of Illinois applicable to contracts to be performed entirely within the state.

3) The wireless internet equipment will be provided by **Reynolds Cable, Inc.** and, in consideration for **Reynolds Cable, Inc.** providing the wireless internet equipment, Customer agrees to pay the application fee and the monthly service fee for a minimum of twelve (12) months. If the service is terminated within the first twelve (12) months, the Customer must continue to pay the monthly service fee for the remainder of the initial 12-month term. Both **Reynolds Cable, Inc.** and Customer may terminate this Agreement at any time, after the initial 12-month term, by giving written notice to the other. Such notice is effective when given and Customer is obligated to pay for service through the termination date.

4) All equipment provided is the property of **Reynolds Cable, Inc.** At the termination of service all provide equipment must be returned to **Reynolds Cable, Inc.** in good working condition. Any equipment damaged through neglect, misuse or abuse will be replaced at the customer's expense. **Customer agrees to protect Reynolds Cable, Inc. equipment from electrical surges by using a surge protector.**

5) Customer is solely responsible for providing and maintaining their own Ethernet capable end access equipment (e.g. PC, Router). This includes providing adequate system virus protection. **Reynolds Cable, Inc.** assumes no responsibility for setup, support, or repair of these devices.

6) All charges will be billed by **Reynolds Cable, Inc.** on **Reynolds Telephone Company** bill on the fifth of each month, payable by the 26th of that same month. Failure to pay by the specified due date may result in your services being discontinued. A reconnect fee of \$15.00 will be required to reestablish service.

7) If your **Reynolds Cable, Inc.** account is discontinued for any reason, **Reynolds Cable, Inc.** assumes no responsibility for recovery of your e-mail data.
