WIRELESS/SATELLITE INTERNET TERMS AND CONDITIONS

- (1) By signing this registration form and agreement, you (subscriber) must be at least 18 years of age and agree to the following terms and conditions of the service described below.
- (2) These services are provided by **Reynolds Cable, Inc. P.O. Box 27, Reynolds, IL 61279** This agreement shall be governed by and construed in accordance with the laws of the state of Illinois applicable to contracts to be performed entirely within the state.
- (3) Services require subscriber to commit to a minimum service term. Subscriber must maintain service during this period or continue payment if service is removed. Commitment period will commence on the date of install and continue for the duration stated on page one (1) of this application.
- (4) All equipment provided is the property of **Reynolds Cable, Inc.** At the termination of service all provide equipment must be returned to **Reynolds Cable, Inc.** in good working condition. Any equipment damaged through neglect, misuse or abuse will be replaced at the subscriber's expense. **Subscriber agrees to protect Reynolds Cable, Inc. equipment from electrical surges by using a surge protector.**
- (5) Subscriber is solely responsible for providing and maintaining their own Ethernet capable end access equipment (e.g. PC, Router). This includes providing adequate system virus protection. **Reynolds Cable, Inc.** assumes no responsibility for setup, support, or repair of these devices.
- (6) All charges will be billed by **Reynolds Cable, Inc.** on **Reynolds Telephone Company** bill on or before the fifth of each month, payable by the 26th of that same month. Failure to pay by the specified due date may result in your services being discontinued. A reconnect fee of \$15.00 will be required to reestablish service.
- (7) If your **Reynolds Cable, Inc.** account is discontinued for any reason, **Reynolds Cable, Inc.** assumes no responsibility for recovery of your e-mail data.

- (11) By accessing and using the **Reynolds Cable, Inc.** network, user is consenting to system monitoring for law enforcement and other purposes. Unauthorized use of, or access to, this network may subject users to criminal prosecution and penalties. User agrees to indemnify **Reynolds Cable, Inc.** against liability for any and all use of user's account.
- (12) Subscriber's internet service may be subject to data limits as indicated on the application page. Packages with data limits include a period each day from 12AM CST to 5AM CST during which any usage is not counted towards the overall limit. When a data limit is met a subscribers service will be stopped or dramatically slowed till the end of their usage period which may vary from a subscribers billing period. A subscriber may check their usage at any time by logging into the usage portal. Additional data may also be purchased in the event a subscriber exceeds their limit.
